## **DURBIN-DUCKWORTH LUNCHEON**



Some of the members of CISCO's Legislative Committee and its Board of Directors had the opportunity to meet and discuss upcoming legislative initiatives with Sen. Dick Durbin (D-IL), US Congresswoman Tammy Duckworth (D-IL 8th), and State Senator Tom Cullerton (D-23rd). The meeting was held on March 26 in Franklin Park.

### **ON THE LEGISLATIVE FRONT**

There is some good news to report in Springfield. State Senator Andy Manar and House Rep. Sue Scherer recently introduced two bills (SB 2393 and HB 3268) that would allow worker's compensation insurance to be based on hours worked rather than wages paid.

Also, House Rep. Luis Arroyo sponsored the Employee Classification Act Amendment (HB 2649) which adds enforcement and investigation provisions for contractors misclassifying workers as independent contractors in order to avoid tax and labor law violations.

On the negative side, our industry's victory with HB 3636 seems to be short lived as the banking industry has countered with HB 2804, introduced by House Rep. Arthur Turner. This bill has been assigned to the Judiciary Committee. We will continue to monitor the progress of these bills with our legislative partners at IMSCA and PAMCANI.
