Minutes CISCO Board of Directors Meeting Friday, December 13, 2013 Maggiano's Oak Brook, Illinois Start time 7:30 AM

- The Minutes from the Friday, September 13, 2013 Board of Directors meetings were read. A
 motion was made, seconded and approved to accept the minutes.
- 2. A motion was made, seconded, and approved to accept the Financial Report presented by Treasurer Frank Furco.
- 3. Talks continue with Fox Valley AGC to fill RCEC vacant board position.
- 4. A motion was made, seconded, and approved to appoint Maurice King to the CISCO board.
- 5. A motion was made, seconded, and approved to name Joe Benson Vice President to fill the vacancy of Michael Wiedmaier.
- 6. President Dave Henderson was pleased to announce that a recent effort to update and clearly define all CISCO employment policies is complete. All members and the director were given copies of the new CISCO Employment Policies. Dave introduced Attorney Terry McGann who explained in detail the new CISCO policies as they relate to among other things, salary, bonuses, healthcare insurance, holidays, vacations, personal/sick days, retirement, mileage and expense reimbursement, non-discrimination, and non-harassment policies.
- 7. In regards to the Non-Discrimination and Non-Harassment Policy a formal process and procedure will be established immediately. The policy will instruct any CISCO employee who feels he or she has been harassed or discriminated to report the incident immediately to the Executive Director. In the event that person is not available the employee shall contact any member of the Board of Directors. CISCO will take all action necessary to investigate and expeditiously address all related complaints of discrimination and harassment. Terry McGann conducted training of all board members in attendance as to their responsibilities under the new policy and how to respond to a comment/complaint from a CISCO employee. In addition, all current and future CISCO employees will be apprised and trained as to the requirements and protections of the CISCO Non-Discrimination and Non-Harassment Policies. A motion was made, seconded, and approved to adopt the new CISCO Employment Policies.
- 8. To insure that all of the previous CISCO employment policies are comprehensively transitioned into the newly adopted CISCO Employment Policies, President Henderson, officers, and the Director Allen will meet to insure this goal is achieved.
- 9. Members read a letter addressed to Former Director Brining, from Attorney Greg Meeder (on behalf of the CBC) requesting CISCO cease with the "Pride and Construction" Awards. Discussions followed, and members agreed that a letter from Attorney Terry McGann in response is appropriate. Also, a meeting between the officers of CISCO and the CBC is tentatively scheduled for the week of January 6th 10th. Results of the meeting will be promptly reported.
