

2011 News & Notes



January:

- Im Underwood, now Executive Director of Construction of the Illinois Capital Development Board, delivered the keynote address at CISCO's Annual Meeting. CISCO presented its Project of the Year Construction Awards, and recognized Linda Hannah of New Skill Builders as Educator of the Year; Ron Ward of the Department of Labor as Labor Conciliator of the Year; and the City of Des Plaines as the Public Body of the Year with Mayor Marty Moylan accepting on behalf of his city.
- An Appellate Court ruling against the \$31 million Capital Bill and its omnibus funding method put the state's capital improvement plan in jeopardy.
- CISCO and the Chicago Regional Council of Carpenters teamed up to host the Construction Challenge for students to acquire hands-on experience in the construction trades.
- € CISCO, the Indiana, Illinois and Iowa Foundation for Fair Contracting (III-FFC), and the DuPage County Building Trades combined efforts to pitch a Responsible Bidder Ordinance to DuPage County and present to the Finance Committee.

February:

- The İllinois Supreme Court granted a stay of the Appellate Court's ruling regarding the constitutionality of the Capital Bill's funding streams, and eventually overturned the ruling in July.
- John Brining was invited to present at the annual Iron Workers Regional Conference -IMPACT - in Orlando, Florida.

- ¶ John Brining met with the Mayors of Yorkville and Oswego regarding a \$3.5 billion solar generation plant being proposed in Kendall County. The multi-year project would create thousands of construction jobs and other economic development related to the project. A coalition of the Fox Valley Building Trades, local Chambers of Commerce, and legislative and business leaders is recommended.
- Navistar announced that work on its Lisle campus is about to commence as General Contractor Duke Realty begins to let out contracts. John Brining is asked to serve as an ombudsman for the procurement process.



● Johnetta Ryan and Julia Mulvey hosted the Hands-On Expo for DuPage County as more than 300 students take part in the two-day event held at the Chicagoland Laborers' Training and Apprentice Center in Carol Stream. CISCO teamed with the College of DuPage's Office of High School Partnerships to offer 11 different trade stations.

March:

The first meetings are held with upper management of Centegra Health Systems in Huntley regarding its plan to construct a \$233 million hospital that would generate 800 construction jobs and add another \$152 million in economic development to the McHenry County region. Centegra's CEO assures CISCO that the project would be constructed using union labor and under a project labor agreement.

CISCO and the DuPage County Building Trades (DCBT) met with the College of DuPage President and facilities managers to present a model project labor agreement for consideration. Voters passed a \$168 million construction referendum for the college to renovate existing buildings and expand its Homeland Security Education Center. The critical support of the measure from CISCO, the Illinois AFL-CIO and DCBT made the difference.

April:

CISCO's Annual Luncheon is highlighted by Keynote Speaker Michael T. Carrigan, President of the Illinois AFL-CIO. Carrigan began by saying "If



you want to see a real professional labor-management group in action, you need to come and visit CISCO. They have set the bar extremely high." In addition, CISCO announced its annual scholarship winners to four high school students entering college. Each received \$2,000 per year, renewable for all four years.

CISCO participated in its first March of Dimes, March for Babies fundraiser, as Team CISCO helped to raise \$2,180.

Navistar selected Graycor Construction as the General Contractor for its Melrose Park facility upgrade. Navistar committed to using only union construction through workers of the Chicago & Cook County Building Trades.

May:



asked to create a board position for CISCO so that Labor had a place at the table of the economic development engine for DuPage County.

CISCO's track record was important to the decision as its support for the Navistar, COD and County Capital Construction projects, were crucial to Choose DuPage. Future projects such as Western Access to O'Hare and projects at Fermi and Argonne National Laboratories will keep Labor engaged where critical construction jobs are at stake.

A Worker's Compensation Reform Bill was passed and signed into law. The most significant change to the Act is a new section which addresses a



collectively bargained worker's compensation "pilot program." Under the new law, the Director of Labor shall designate two labor organizations to participate in the pilot program, and work is underway to expand the number of local union participants.

2011 News & Notes

June:

ℂ CISCO welcomes four dynamic new companies as associate members: Culloton Strategies, LLC; Delta Dental of Illinois; Kovitz Investment Group and Navistar.



CISCO began working with Unimar Public Relations on an update to its web site. The plan was 1) build a more modern look and feel, 2) improve interactive features, 3) create a new .NET platform for ease of web management, 4) add social media links, 5) develop e-mail marketing, and 6) add data tracking and analytics for an August launch.

July:

■ John Brining attended a meeting with Governor Quinn regarding the \$3.6 billion Western Access to O'Hare Airport. The bypass will connect with I-90 to the north near Des Plaines and the Tri-State to the south in Franklin Park. The road will also link with the eastern segment of the Elgin-O'Hare, which terminates in Itasca now, and would be located along Thorndale Avenue.



State officials estimate the project could create as many as 21,000 short-term jobs and 60,000 long-term jobs, based on economic development in the form of industry, hotels and retail that would form along the western half of the airport.

August:

■ Johnetta Ryan, Gary Karafiat and John Brining spoke in support of the Tollway's \$12 billion Capital Plan at Public Hearings in Chicago Ridge, Geneva, Wheaton, Schaumburg and Buffalo Grove. Later in the month, the Tollway Directors voted to approve the 15-year plan that will create more than 120,000 permanent jobs and add \$21 billion to the economy. For every \$1 billion of annual construction, more than 13,000 construction-related jobs will be created.



September:

Leon LaJeunesse, founder and President of Lake Zurich-based Custom Contracting, Ltd., joined CISCO's Board of Directors. He began his career as a millwork apprentice and after years of increasingly responsible positions, founded Custom Contracting, Ltd., in 1987. He is the President and COO and manages all key personnel and core operations.

CISCO worked with Argonne National Laboratory (ANL) and its procurement team to host an informational meeting for approximately 75 union contractors and members of building trades organizations regarding opportunities to bid and perform work at ANL. The workshop allowed the participants to ask many questions about the procurement process and ANL requirements.

Labor and management came together for a double-header presentation led by Mark Breslin. Nearly 20 distinct organizations comprised of labor unions and signatory trade associations served as sponsors of this unique event. Planned by the staffs of CISCO, PAMCANI and FCAC (Finishing Contractors Association of Chicago), the net proceeds of \$5,000 are being donated to the Aurora Interfaith Food Pantry, Chicago Food Depository and the Northern Illinois Food Bank. The two sessions - "The Perfect Storm" and "Alpha Dogs" - were well received. The Perfect Storm was aimed primarily at union leaders and business owners in the construction trades, while Alpha Dogs focused on management, mentoring and motivation - ingredients needed to form competent and visionary leaders.



This year's "Last Swing" Golf Outing at Bloomingdale Golf Club had special significance as CISCO put the word out that the proceeds of the 2011 event were going to help fellow union families who are need in of assistance. The Chicago Food Depository and the Northern Illinois Food bank were designated to receive the funds that remained after financial obligations were met. And boy, did CISCO members and supporters step up! Nearly \$3,000 will be split evenly to the two charities as golfers and sponsors contributed in near-record numbers. The course was sold out, and the weather was again perfect for a third consecutive year. In addition, the luncheon was highlighted by some lucky raffle prize winners.



October:

CISCO held workshops for the Lake County, McHenry County, DuPage County and Fox Valley Building Trades to discuss changes to the Prevailing Wage and Freedom of Information Acts, as well as to layout the benefits of Responsible Bidder Ordinances. The seminars were well attended and CISCO will continue to provide these important educational opportunities. (See page 13.)

November:

Gary Karafiat and John Brining spoke in support of the \$60 million Freedom Plaza (Embassy Suites & Alzheimer's Care facility) project in Naperville. The first-class hospitality facility would provide a \$154 million economic impact for the region. In Naperville, the project would mean 1000 jobs and nearly \$1 million in tax revenue.

December:

- CISCO continues to work with the Chicago Cubs and the Chicago & Cook County Building Trades on a \$400 million Wrigley Field renovation plan. Ricketts had asked CISCO, labor leaders and neighborhood groups for their support.
- CISCO joined forces with the Chicago Public Schools to offer a Hands-On Expo for 240 students as 12 different trades were on hand at the Regional Council of Carpenter's Training Center. This was CISCO's 10th year of sponsoring this twoday event.

Education-to-Careers



Johnetta Ryan *Education-to-Careers Director*

CISCO established the Education-to-Careers program in 1998 with the primary mission of promoting careers in the union construction apprentice programs through a variety of initiatives.

Johnetta Ryan, the program's Director, delivers a comprehensive speaking and multimedia presentation that outlines the basics of the programs and spells out the requirements to enter each trade. Ryan gives this presentation at schools, community groups, faith-based organizations, and many others. Ryan also participates in career fairs at area high schools and community colleges. A list of the groups she visited in 2011 can be found on the opposite page. CISCO also publishes "Build Your Future," a guide to apprenticeships in our six-county service area.

Students have historically been a challenging segment of the population

to draw toward the union building trades. In addition to the informational program that Ryan presents, CISCO also partners with building trades, employer groups, and educators to coordinate multiple yearly Hands-on-Construction fairs where students and teachers learn about trades from the tradespeople themselves and have a chance to use tools and find out what they can expect from a career in union construction.



In 2011, CISCO started a new initiative aimed at visiting more junior high school age students. This idea was a logical change for CISCO to undertake, because today's students need to be exposed to the idea of a career in the trades at an earlier age. The hope is that when junior high school age students begin graduating from high school in 5 to 6 years, apprenticeship programs will be accepting applications near the same volume



that they were prior to the downturn in the economy. A more practical reason for the strategy is that it allows junior high students to learn which classes they need to take in high school in order to be prepared for a career in the trades. In addition, the program lets the students know at an earlier age that there are options available to them in areas other than college.

The first phase of this new initiative involved mailing letters to every junior high school counselor within the City of Chicago Public School System. Future efforts will involve contacting schools within the suburban counties of CISCO's service area.

Legislative Committee

CISCO's Legislative Committee spun off from the Fair Contracting Committee in 2005 as a means to keep representatives of labor and management involved in the legislative process and aware of current and pending legislation affecting the union construction industry.

Legislative tug and pull in Springfield concerning the budget, the uncertainty of the Capital Bill, worker's compensation reform, and the continued debate over gaming expansion were the top stories



of 2011. In the end, both sides of the aisle came to a budget agreement thus avoiding the cancellation of many roadway construction projects. In another close call, the \$31 billion Capital Bill, signed in 2009, was nearly derailed by a lawsuit contending that the Bill had violated the "single-subject" rule. But, in July, the Illinois Supreme Court overturned an appellate court decision, and ruled that the bill was constitutionally sound. Both the budget and the Capital Bill have major implications on construction work and jobs, and the results were favorable to our industry.



A Worker's Compensation Reform Bill was passed and signed into law. The most significant change to the Act is a new section which addresses a collective bargaining "pilot program" that applies to businesses involved in construction. Under the new law, the Director of Labor shall designate two labor organizations to participate in the pilot program, and work is underway to expand the number of local union participants.

Gaming Expansion is still a hot topic as Governor Quinn's objection to including slot machines at Illinois racetracks has the bill in limbo. At least \$500 million of construction work covered under project labor agreements to build these new facilities at racetracks is in jeopardy.

Many other legislative issues were discussed (see box) throughout the year that will have an impact on the union construction industry.

CISCO's primary role in the Legislative Committee is to facilitate the meetings and encourage open discussion on all issues brought to the table. As an organization, CISCO does not take an official stance until it reaches a consensus agreement among its Board of Directors.

Fair Contracting Outreach


CISCO's involvement in Fair Contracting has evolved over the years, and for the past three years, CISCO's partnership with the Attorney General's Office, the Illinois Department of Labor and the Indiana, Illinois and Iowa Foundation for Fair Contracting has benefitted many of our members, contractors, building tradesmen and public body employees. CISCO held workshops in October for the Lake County, McHenry County, DuPage County and Fox Valley Building Trades to discuss changes to the Prevailing Wage and Freedom of Information Acts, as well as to layout the benefits of Responsible Bidder Ordinances. The seminars were well attended and CISCO will continue to provide these important educational opportunities.



With respect to Responsible Bidder Ordinances (RBO), CISCO continued to work to educate public bodies such as DuPage County, the City of Naperville, the City of Des Plaines and the DuPage County Forest Preserve District on the benefits of this ordinance. With cities such as Aurora, Bolingbrook, Elgin and Romeoville having recently passed an RBO, the success stories are piling up as more than 125 public bodies have adopted such an ordinance. At the time

of printing this publication, CISCO learned that the City of Des Plaines recently adopted a Responsible Bidder Ordinance. We are proud to have played a role in the decision and thank Mayor Marty Moylan for his support.

CISCO also worked with Argonne National Laboratory (ANL) and its procurement team to host an informational meeting for approximately 75 union contractors and members of building trades organizations regarding opportunities to bid and perform work at ANL. The workshop allowed the participants to ask many questions about the procurement process and ANL requirements.





CISCO remains actively involved in the Illinois Prevailing Wage Council as Executive Director John Brining serves as an officer on its Board of Directors. The Council is a voluntary member organization dedicated to preserving and strengthening the laws that protect men and women who work in the building and construction trades industry. CISCO continues to monitor Prevailing Wage law changes, and in 2011, Governor Quinn signed House Bill 3237 which changes the penalty for violating the Act to a Class A misdemeanor (carrying a maximum one year prison sentence), and requires the Department of Labor to debar (prohibit working with the State) violators for 4 years.







In 2003, CISCO created a marketing campaign called Built Right to counter the misinformation being disseminated about union construction workers and contractors, and it continues to be an effective tool.




The campaign is geared toward architects, engineers, developers, and space planners. Research has shown that these professions would receive the most benefit through increased awareness of what union labor brings to the table.
